Racketeering and Criminal in Law Notion

- **□** Racketeering cumulative components:
 - Intense recurrent and organized activity;
 - Aim regularly acquiring revenue or other material benefits;
 - Personal Element Intention and previous criminal record
 - Number of Commission at least twice within 5 consecutive years;
 - □ Racketeering Group a legal person or any association of physical or legal persons related to racketeering

Racketeering and Criminal in Law Notion

☐ Criminal in Law:

- Personal Belief any person recognizing the Criminal World;
- Act actively participating to its ends;
- Criminal World Cumulative Components:
 - <u>Unity</u> Any community of persons, acting set/recognized rules;
 - Personal Belief having the intention to get the benefit for their own self or for the other members;
 - Means of activity intimidation, threat, coerce, silence order, criminal solution, involvement of a juvenile in criminal action, commission of crime, instigation to crime

Racketeering and Criminal in Law The legal source of Criminal Liability

- ☐ Criminal Law Racketeering:
 - Quality Aggravate subsection of Extortion (Article 181)
 - Disposition Crime: Participation in a Racket Group.
 - ☐ Participation in a Racket Group Alternative Components:
 - Activity Steering racket group independently or with others, or other sort of participation in racket group; also
 - Dispute solution in illegal way between racket groups or between racket and other sort of groups or participation in it.

- ☐ Criminal Law Criminal in Law:
 - <u>Disposition</u> Crime: Membership
 Criminal World; Criminal in Law.
 - ☐ Membership of the Criminal World; Criminal in Law:
 - Status Being the member of this world;
 - ➤Aggravation Being a Criminal in Law

- ☐ The basis for the Criminal Investigation from 2005
 - > Any element of crime in the action;
- Expiration of limitations for the defendants:
 - Reducing of pre-trial detention from 9 month to 4 month;
 - Reducing of status period of the accused from 24 to 12month for the same charge.
